### Invitation for Prequalification of Vendors for provision of Transport Services for different duties at NUMS

**National University of Medical Sciences (NUMS)** invites applications from reputable and experienced transport service providers to prequalify them for provision of transport services for different duties at NUMS. The prequalification process will be conducted in accordance with **PPRA Rules**. **Eligibility Criteria:** Interested firms must meet the following requirements:

- **Experience:** Minimum five (5) years and above experience in providing transport services to public and private sector organizations.
- **Registration:** Must be registered with relevant authorities and possess valid GST and Income license and should be listed as Active Taxpayer status with the FBR.
- **Subcontracting:** upon selection, subletting of the contract is not permissible.
- **Integrity:** The firm must **not be blacklisted** by any government or private organization.

Prequalification documents / proposals must be submitted in a sealed envelope.

**Submission Deadline:** Last date for submission of proposals/applications is **Wednesday, 19<sup>th</sup> March-2025 by 11:00 AM**. All submitted documents will be opened by Tender Opening & Evaluation Board on same day of closing date at 1130AM in **Board Room-7, NUMS Secretariat, C/O PEMH, The Mall, Rawalpindi** in the presence of participating firms or their authorized representatives.

**Evaluation Criteria & Selection Process:** Submitted applications will be assessed based on compliance with eligibility criteria, documentary evidence and relevant experience of the participated firms. Submission of documents without valid and supporting documentary evidences will be straight away liable for rejection. No amendments, addition, deletion, revisions, or supplements regarding submitted documents will be entertained. Qualified firms will be informed in due course of time and invited to submit financial proposals through a formal request as and when required.
