  - Financial statements/audited reports of the firm/company since last three (3) years.
  - Valid certificate of authorized agent of manufacturers for vertical transportation system.
  - List & CV of key personnel & permanent staff employed.
  - List & Cost of similar projects in hand, including particulars of client(s) and scope of completed works along with work order(s).
  - Detail information about similar projects successfully completed in last five years alongwith Completion Certificates.
  - Satisfactory maintenance of service certificates for executed projects during last five (5) years.
  - List of special equipment, tools, machinery, spare parts and inventory maintained by the firm.
  - Affidavit on Stamp Paper of Rs. 100, that the Company has not been black-listed by any Government/ Semi Government Organization and there is no litigation case subjudice in court of law.
  - PEC Standard marking criteria for pre-qualification of bidders and PPRA guidelines shall be followed.
